THE MINISTER OF AGRICULTURE, NATURE AND FOOD QUALITY,

Deciding, in agreement with the Minister of Health, Welfare and Sports, on the application dated 17-11-2021 of **Orly Pharma B.V.** in **Venlo** to obtain a changed license for the wholesale trade of veterinary medicines, with regard to the possession of, trade in and provision of veterinary medicines as meant in Section 2.19, subsection one, of the Dutch Animals Act (*Wet Dieren*), in conjunction with Article 5.1, paragraph one, of the Dutch Veterinary Medicines Decree.

DECIDES

A changed license under number **2887-GL** is granted to **Orly Pharma B.V.** as of the date of this Decision, for the wholesale trade in channelled veterinary medicines and veterinary medicines available without a prescription from a veterinarian (GL);

because following the assessment of the application it appears that the conditions have been met that are set out in Section 2.19, subsection three, of the Animals Act and the other conditions set in or pursuant to the Animals Act.

This license is valid for an indefinite period of time.

The license exclusively relates to the premises situated on the parcel of land **Ir. Wagterstraat 8, Boxmeer**, as further indicated on the map attached to the application.

The license will be entered into the register as meant in Section 7.2, subsection one, of the Animals Act, read in conjunction with Article 5.6, paragraph two, of the Veterinary Medicines Decree.

The license can be changed or withdrawn as meant in Article 5.5 of the Veterinary Medicines Decree and Article 9.1, paragraph 5, of the Veterinary Medicines Regulation, if the requirements or restrictions determined in the license are not complied with.

Any interested party may submit a notice of objection to this Decision to the Minister of Agriculture, Nature and Food Quality, stating the reasons. If a notice of objection is submitted, this has to be sent within 6 weeks after the date of this Decision in the Government Gazette, to:
